The meeting will be held in the Library of Congress Madison Building, 101 Independence Ave. SE, Washington, DC 20540.

Main entrance is on Independence Ave.

There is no public parking in the library buildings. Paid parking information in the surrounding area can be found here:

If you are taking the Metro (<https://wmata.com/>), the closest stop is Capitol South (Orange/Blue/Silver Lines) - the exit will put you on First Street SE. Go up the hill towards the Madison Building and turn right to get to the main entrance on Independence Ave.

If you are taking the MARC (<https://www.mta.maryland.gov/welcome-back-to-marc>) or Amtrak train (<https://www.amtrak.com/home.html>), get off at the Washington Union Station station stop. Cross Columbus Circle and walk south on First St. for 5 blocks until you reach Independence Ave. Cross Independence Ave. (past the Jefferson Building) and enter the Madison Building.

Security at entrance/exit

The Library of Congress buildings require going through Capitol Police security gates in order to enter. Put all belongings on the x-ray conveyor belt. Remove all items with metal in them (belts, watches, loose change, some jewelry will set off the alarm) and place them in the provided tray. Put laptops in a separate tray. You will not need to take off your shoes unless they have metal in them. Walk through the gate and collect your belongings at the end. Capitol Police will confiscate items that they deem as dangerous, so please leave them at home.

When exiting the building, you will need to open your bag to the police, and if you have a laptop, you will be required to show this as well.

Once inside the Madison Building

Turn right just past the hall to the elevators. Take the elevator to the **6th floor**. The meeting will be held in **Dining Room A** (which is a meeting space, not a dining hall) in the **Yellow Corridor**.

A display of Music Division collection items will be in the **West Dining Room** on Friday during check-in only.

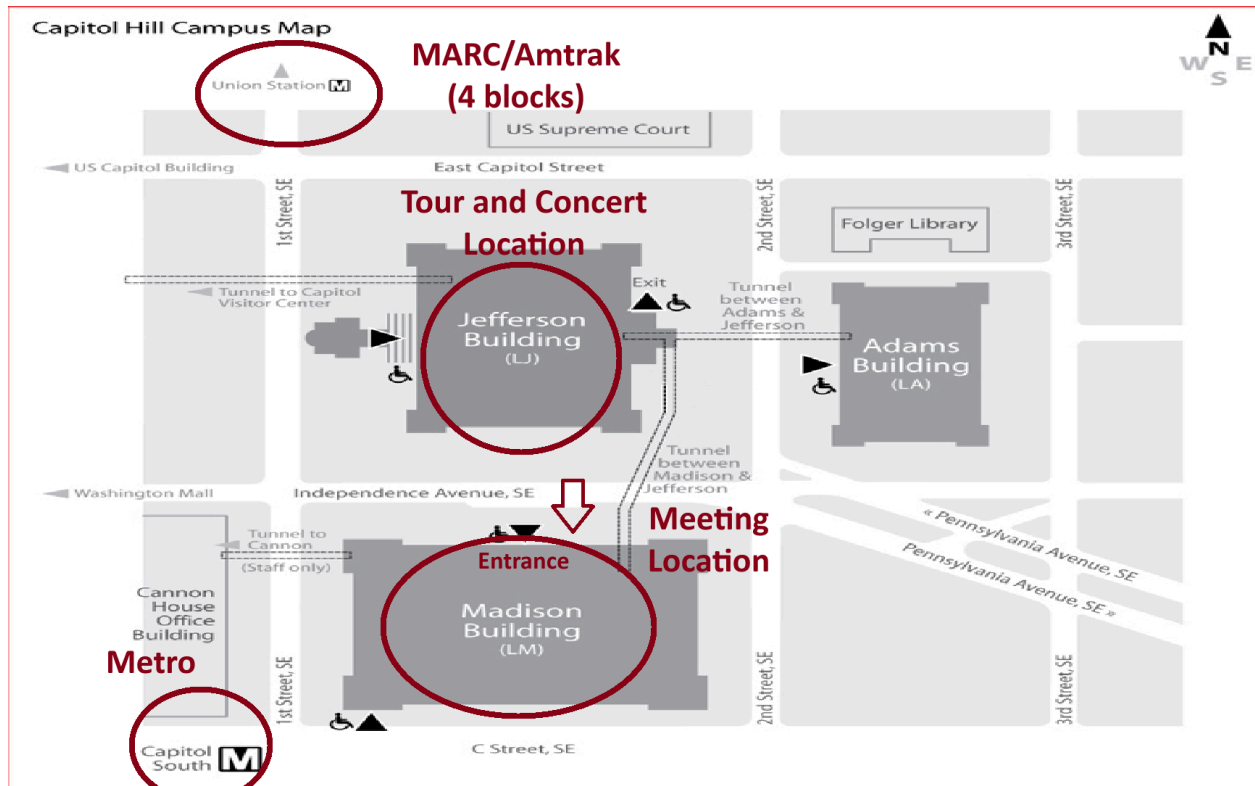

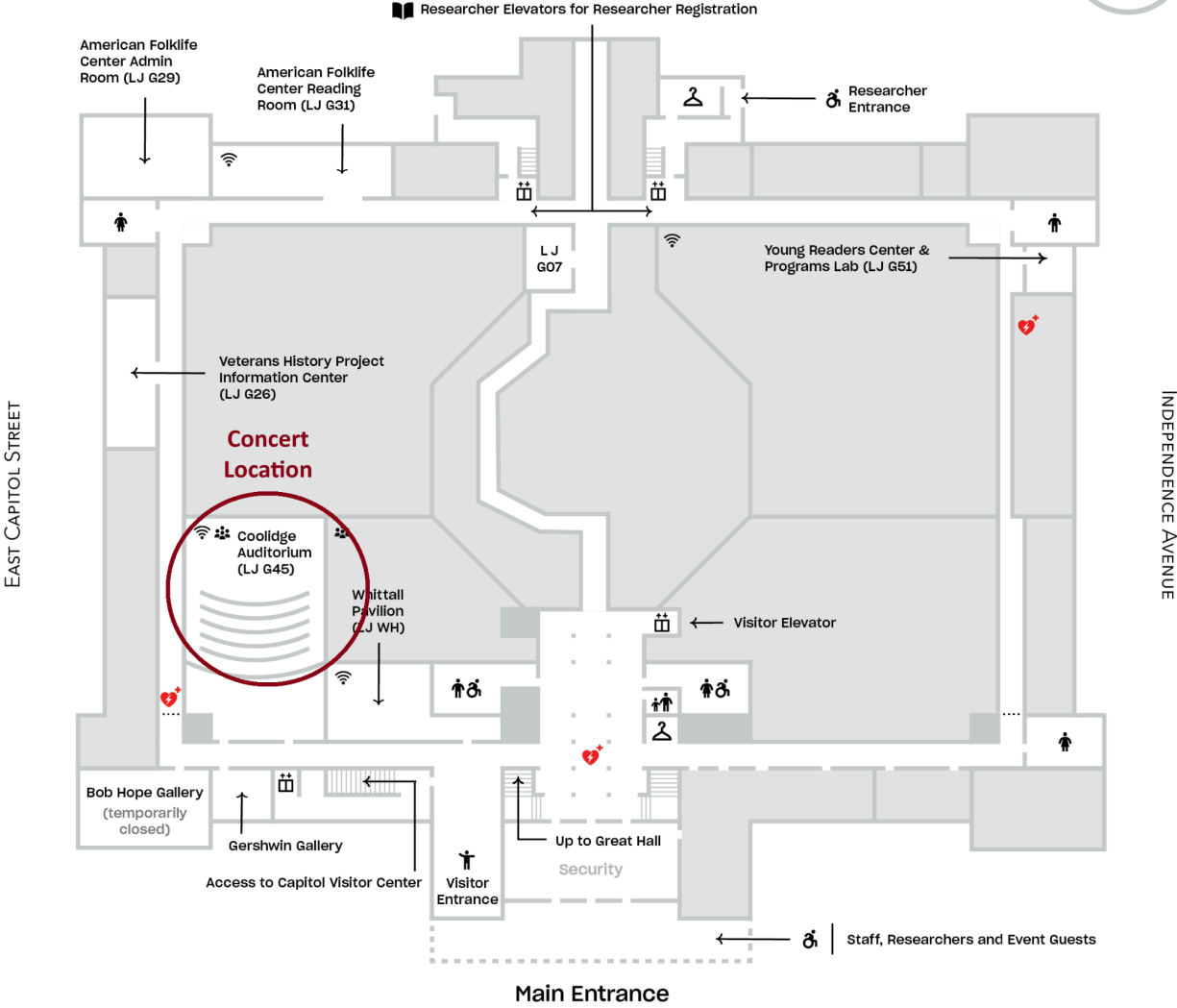

2ND STREET, SE

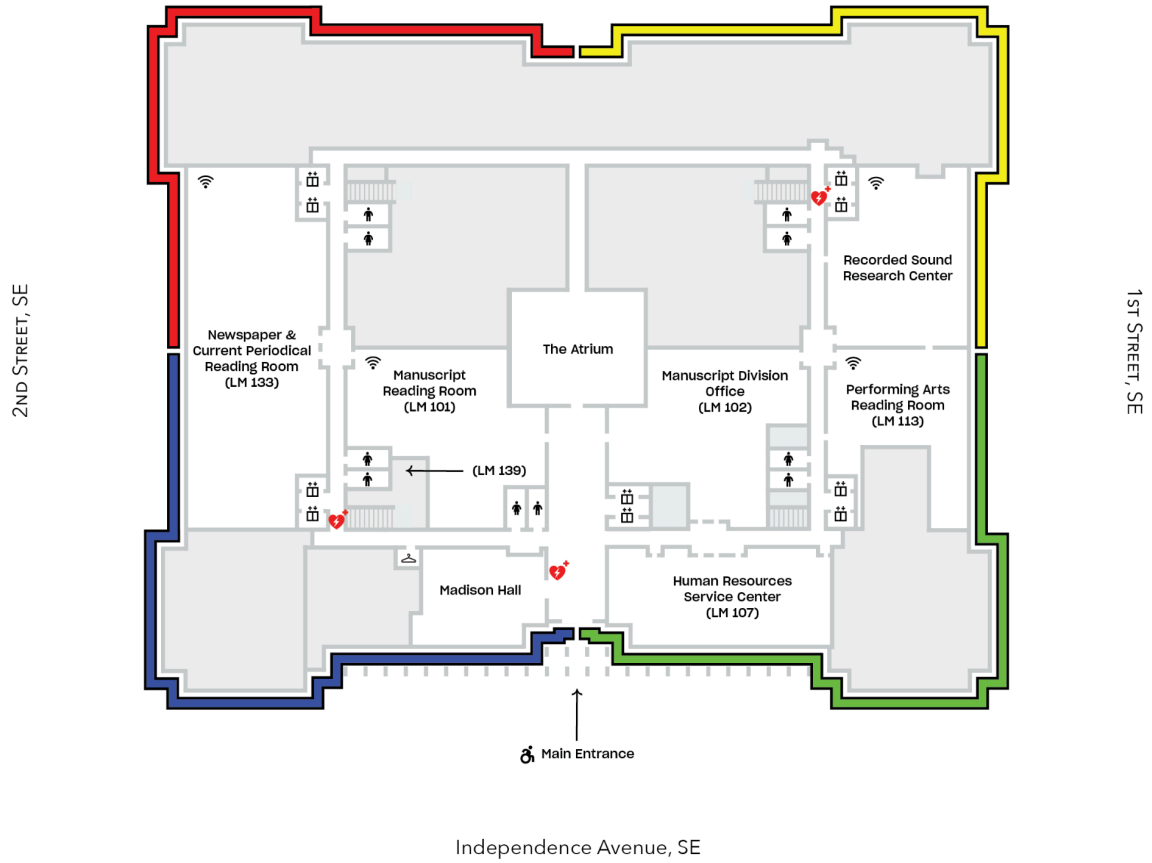


1ST STREET, SE
